OPEN SESSION:

Rulemaking Update – Brandon Williams, Program Manager

- 3.1. [ESSB 5229](#) requires all professions that require continuing education (CE) to include a health equity training as part of CE requirements starting January 1, 2024. Now that the Department of Health has updated its rules regarding continuing education consistent with the new law, the committee will need to decide whether to accept the minimum requirements of two hours every four years or some other standard so long as it meets the minimum requirements. Next steps – A CR-101 will be filed to open the continuing education section of the rules.

Open Discussion of SOTP Advisory Committee – Corey McNally, Chair

- 4.1. Mr. Knoepfler announced that there will be a discussion at the next WATSA meeting regarding public disclosure reports. Mr. McNally mentioned that SOPB will also have a recommendation regarding how many public disclosure requests there may be. Ms. Hardenbrook and Mr. Nelson volunteered to help with weekly legislative calls.
