Dear Mr. Stowell:

Enclosed is Replacement Authorization (RA) #092 issued to Fresenius Medical Care approving the replacement of FMC Aberdeen Dialysis Center to a new site within Grays Harbor County. At project completion, FMC Aberdeen Dialysis Center will have 16 approved stations as noted on the certificate and described in the application.

Replacement Authorization #092 is valid for two years. The project must begin during this time. If there is substantial and continuing progress, we may extend the authorization for one six month period. For an extension, you must submit an extension request at least 120 days before the expiration date. You cannot begin a project after the expiration date.

This decision may be appealed. The two appeal options are listed below.

Appeal Option 1:

You or any interested or affected person may request a public hearing to reconsider this decision. The request must state the specific reasons for reconsideration in accordance with Washington Administrative Code 246-310-560. A reconsideration request must be received within 28 calendar days from the date of the decision at one of the following addresses:

Appeal Option 2:

You or any affected person with standing may request an adjudicative proceeding to contest this decision within 28 calendar days from the date of this letter. Description of Approved Project


Fresenius Medical Care is approved to relocate FMC Aberdeen Dialysis Center to a new site in Grays Harbor County as allowed under WAC 246-310-289 provided that Fresenius Medical Care agrees to specific conditions. On April 4, 2018, Fresenius Medical Care agreed to the following conditions.

Conditions of Exemption Approval

1. FMC Aberdeen Dialysis Center is approved to certify and operate 16 dialysis stations at the new site.
2. CN #1627 issued on January 5, 2018, approves the addition of 8 dialysis stations to the 16-station center. CN #1627 was issued with an approved project description and four conditions. This relocation approval does not invalidate the issued CN, project description, or conditions attached to CN #1627.

This Replacement Authorization is effective from April 5, 2018, through April 5, 2020, unless extended, withdrawn, suspended, or revoked in accordance with applicable sections of the Certificate of Need law and regulations.
