Activities in the Growing Area in 2023

The growing area was sampled six times in accordance with the National Shellfish Sanitation Program (NSSP) Systematic Random Sampling (SRS) criteria. No additional activities have been documented in the growing area.

Analytical Results of Water Samples

Table 1 summarizes the results of the last 30 samples collected from the area. This summary shows that all stations pass the NSSP water quality standard. Station 228 only has 29 samples.

Change in Actual Pollution Sources that Impact the Growing Area

We currently have no information indicating that the area has new sources of pollution.

Classification Status

- Well within the classification standards
- Meets standards, but threatened with downgrade in classification
- Fails to meet current classification standards

Remarks and Recommendations

Table 1 shows that all stations meet the NSSP water quality standard for an Approved classification and the area is correctly classified.

* N/A – SRS criteria require a minimum of 30 samples from each station.

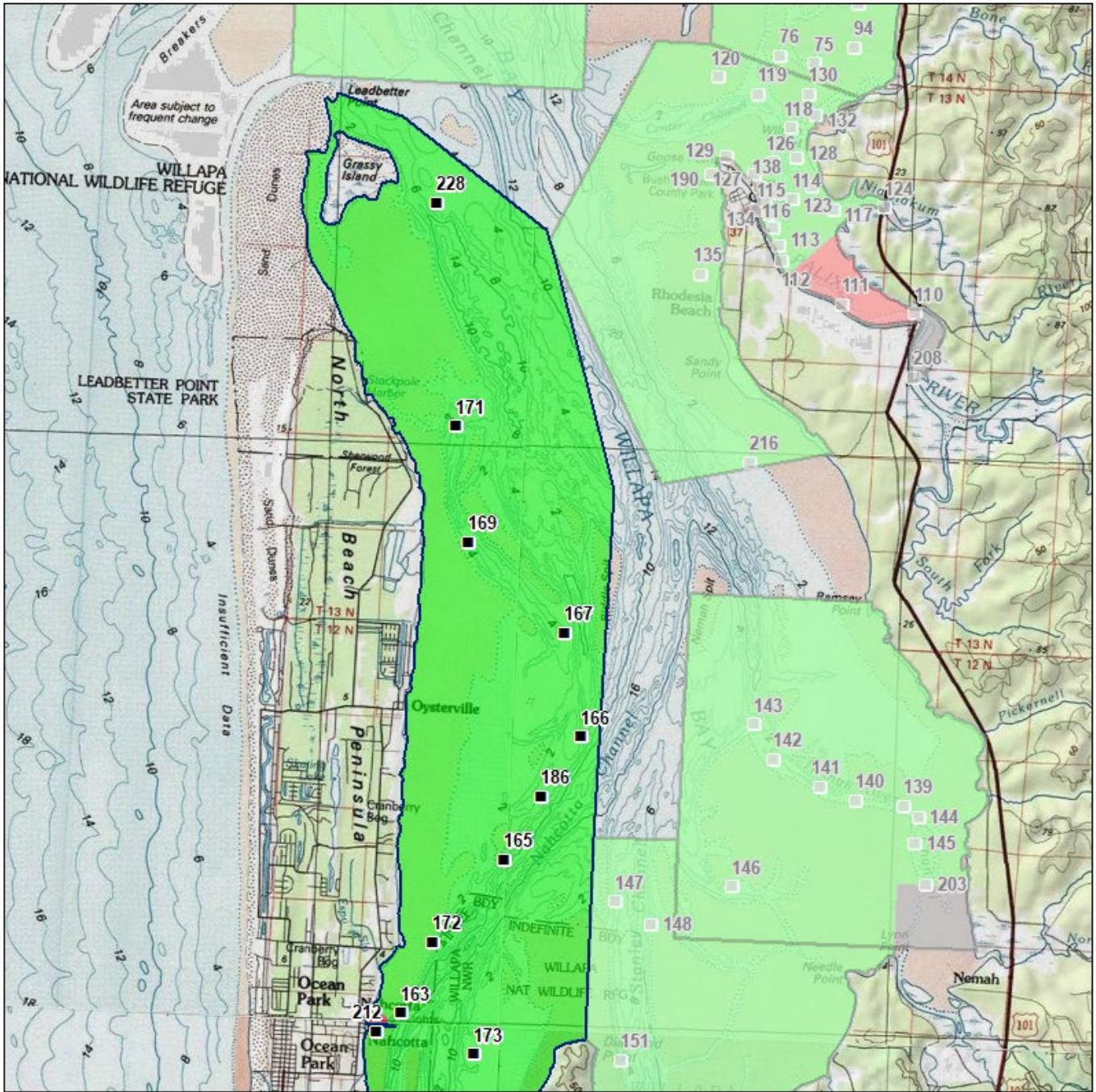
MAP 1. Nahcotta Growing Area (1 of 2)

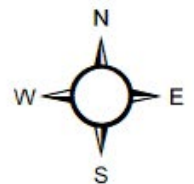

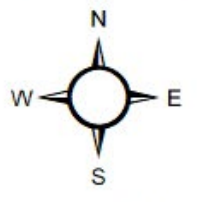
MAP 2. Nahcotta Growing Area (2 of 2)
